**MEMBERSHIP AGREEMENT**

**Members will be subject to all Club Rules, Regulations and to the following;**

1. Members will be responsible for damage to any property of the Club, caused by member or member`s family, guests or invitees.
2. Membership fees are not refundable and membership privileges are not assignable, unless approved by the Club.
3. Membership privileges may be revoked by the Club for violation of the Club`s rules and regulations.
4. Use of the Club facilities is at the sole risk of the member, and member waives any claim for loss or damage to member`s property in connection with member`s use of the facilities.
5. Member agrees to hold the Club harmless for any and all injuries incurred while on the Club property.
6. Annual Membership expires on December 31, 2007 following application approval unless otherwise extended by club management, or terminated for violation of the Clubs rule and regulations. Any renewal is subject to approval by the Club at its sole discretion.
7. All facilities, equipment, hours, prices, services, rules, regulations and policies of the Club are subject to change at the sole discretion of the Club.
8. Member acknowledges that membership is not an investment in the Club. Annual Dues are pre-paid user fees, and do not create or convey a legal equitable property interest of any kind, nature, right or description whatsoever in either the Club or the Club facilities.
9. A Members use is limited to the facilities at Huntmore Golf Club and does not extend to any other properties and / or businesses.
10. Member acknowledges that the entire property or a portion thereof known as Huntmore Golf Club may be closed from time to time at the discretion of the Club, for special events and routine or necessary maintenance and repairs. Such events or routine maintenance and repairs will not cause the Member to receive any additional consideration or reimbursement for the lost time and opportunity.
11. Member acknowledges that Huntmore Golf Club is sole owner of the Club and all related facilities with the sole right to operate the Club and such facilities. These rights include but are not limited to:
  - a. The right to change or discontinue operation of the Club facilities.
  - b. The right to exercise any and all other rights of ownership including the right of sale to others.

Membership in the Club will be governed by these terms, conditions, and the Club rules and regulations. The Club at its sole discretion will determine such terms, conditions, rules and regulations. Ownership of a home that may border the facility confers no membership rights upon the owner of such home, nor any right to make application for membership, nor any right to make use of the golf course or other related facilities. Fees charged for the use of the golf course, clubhouse and membership in the Club are subject to the sole discretion of the Club and are subject to change. No representation is made regarding the type, availability or number of memberships that the Club may offer from time to time.
